	Board Chair, Dr. McCants reported to the public that a meeting was convened for all of the interprofessional boards at a live symposium in	

which Dr. Allison Hill was in attendance. Dr. McCants thanked Dr. Hill for representing the DC Board of Pharmacy during the symposium.

Dr. McCants further reported that there will be Council hearings held on December 7, 2023, on the District's healthcare workforce. The hearings will discuss bills including the Health Occupations Revision General Amendment Act of 2023 (HORA). This includes the expansion of the Pharmacy Practice Act and the addition of the Board's Pharmacy Technicians as a proposed update. Dr. McCants congratulated the Board of Pharmacy for pushing the proposed amendments through.

Vice Chair, Mr. Alan Friedman asked the following question:" If the bill goes in front of the full council, would the bill likely either pass or die or would it be sent back to the committee?"

Senior Assistant Attorney Counsel, Carla Williams reported that the council will go back and make changes if they feel some were needed. If there are further markups, it will likely then come back in front of the council at some point. If it doesn't pass on December 7th, in theory when the committee makes changes, that information does come back out again in a very public manner.

 National Association of Boards of Pharmacy (NABP) New Pharmacist Exam Eligibility Service

Executive Director, Dr. Ortique informed the public that effective November 14, 2023, the DC Board of Pharmacy will utilize the *National Association of Boards of Pharmacy* (NABP) *New Pharmacist Exam Eligibility Service* to enhance the pharmacist licensure process.

The examination eligibility service will help confirm candidates' eligibility to take the NAPLEX and MPJE on the board's behalf. Once verified, NABP staff willindicate the candidate's eligibility through the e-Profile Connect.

Office of Government Relations (OGR) Report Updates

Health Occupations Revision Act (HORA) Update:

- DC Health worked on a significant revision of the HORA. This would be the first significant revision in seventeen years.
- The revised HORA received Mayoral approval and has been introduced to the Council as the *Health Occupations Revision General Amendment Act of 2023* (B25-0545).
- A hearing is scheduled for December 7th.

DC Health Director Appointment:

• Director Bennett's nomination was unanimously voted out of the Committee on Health and was then unanimously approved by the entire Council on November 7th.

Health Professional Licensing Boards Residency Requirement Amendment Act of 2023:

- Councilmembers Henderson and Parker introduced the *Health Professional Licensing Boards Residency Requirement*Amendment Act of 2023 (B25-0312) on June 2, 2023.
- This legislation permits non-District residents to serve on health professional licensing boards.
- There are restrictions, including that the Board Chair and Consumer Members are still required to be District residents and no more than 50% of the Board could be made up of non-District residents.
- This bill received a hearing on July 13, 2023. DC Health testified during this hearing and expressed support for the need for innovative solutions to fill board vacancies and offered some changes to the bill. It was voted out of the Committee on Health during a markup on September 26th and was passed on the first reading by the Committee of the Whole on October 3rd.
- The bill was passed on final reading on November 7th and is awaiting Mayoral approval.

Prescription Drug Monitoring Program Amendment Act of 2023:

- Chairmen Mendelson, at the request of the Mayor, introduced the *Prescription Drug Monitoring Program Amendment Act of* 2023 (B25-0244), on April 11, 2023.
- This legislation seeks to make changes to the disclosure of information through the District's Prescription Drug Monitoring Program (PDMP). These changes would give DC Health the authority to release additional de-identified information for statistical analysis, research, education, or grant applications.
- This bill received a hearing on <u>July 6, 2023</u>. DC Health testified in support of the bill highlighting the importance of data sharing as a tool to advance population health in the District of Columbia. A

- markup was held on October 10, 2023, during which it was unanimously approved. The committee makes changes based on feedback from stakeholders during the hearing (requiring the funds generated from any fees charged under the program to be deposited in a special purpose revenue fund held by DC Health).
- The bill passed its first reading on November 7th and is awaiting its second reading in the next legislative meeting on December 5th.

Opioid Epidemic Roundtable:

- The Committee on Health hosted a public roundtable on October 26th at 10:00 am to declare the opioid and fentanyl crisis in the District a public health emergency.
 - Dr. Barbara Bazron, Director of the Department of Behavioral Health (DBH), provided testimony and was joined by DC Health Acting Director Bennett and Dr. Robert Holman, Medical Director at the District's Fire and EMS Department.
 - The roundtable focused on available data related to the ongoing opioid crisis and the District's LIVE.LONG.DC. strategy. You can watch the hearing at the following <u>link</u>.
- Mayor Bowser issued a Public Emergency on November 13 to give the District new tools for responding to the Opioid Crisis

IBC Symposium

Executive Director, Dr. Ortique informed the public that the IBC Symposium was held here at DC Health. DC Health board members were essentially brought together from different boards to work collaboratively together.

The meeting first started with a greeting from the Director of the Department of Health (DC Health), Ayanna Bennett, MD, MSPH, FAAP. Dr. Bennett gave a brief overview of DC Health and how public health works to improve population health. In addition, there were several presentations, one that included artificial intelligence which was presented by former HRLA Associate Director and former Executive Director of the Board of Medicine, Mr. Frank Myers. Dr. Ortique further reported that it was really interesting how AI is shaping healthcare and how we address it legislatively. There can be problems utilizing AI as well, but definitely, a tool that can be leveraged.

The symposium closed with working group case studies.

Prescription Drug Monitoring Program Updates:

Dr. Ortique reiterated that pharmacists who are licensed in the District of Columbia are required to register with the DC Prescription Drug Monitoring program within 90 days. The Program staff will continue to send out monthly notices to individuals who do not register within 90 days and who are subject to potential fines.

Dr. Ortique further reported that the DC Prescription Drug Monitoring Program has a PDMP Advisory Committee. The next committee meeting will be held on Tuesday, January 9, 2024. Access to the meeting WebEx will be posted on the following website: https://dchealth.dc.gov/node/936512. Dr. Ortique reported that the January meeting should be a very lively discussion as they have added new members from DBH, the DC Healthcare Finance, and the Office of the Chief Medical Examiner. DCRx (DC Center for Rational Prescribing) Dr. Ortique reported to the public that the last module is scheduled to be released by the following week or by the end of the year at the latest. Dr. Ortique further reported that the new module will take an inclusive sexual history. This will essentially be a very good module as it also provides case examples in different vignettes with actors who act out different scenarios to ensure that practitioners are providing inclusive sexual history before patient encounters. **Board of Pharmacy Vacancies:** Lastly, Dr. Ortique wanted to reiterate that the DC Board of Pharmacy has two consumer member vacancies. If you are interested in becoming a consumer member, you can apply through the following link: https://motaboards.theresumator.com/apply/1L8k6Q/Board-Of-**Pharmacy** Senior Assistant **General Counsel** Report 1207-0-02 **Notice of Final Rulemaking** Ms. Carla Williams (a) Chapter 25, Health Professional Reporting Requirements, of Subtitle B, Public Health and Medicine, Of Title 22 DCMR, Health Senior Assistant General Counsel, Carla Williams reported that Chapter 25, Health Professional Reporting Requirements, of Subtitle B, Public Health and Medicine, Of Title 22 DCMR final rulemaking took effect back in 2021. The rule making affects all pharmacists, pharmacy interns, technicians, and their employers. The rulemaking was added to require all licensed, registered, or certified health professionals and all employers of licensed, registered, or certified health professionals to report certain information within ten (10) days of them occurring. Those reporting requirements are:

	 If you've been named in a malpractice suit and received notice of a judgment against him or her in that suit; or If you've been convicted of a crime; or If a disciplinary action has been taken against you in another state or jurisdiction. If you've been a part of a party to a settlement, whether or not confidential, stemming from a malpractice claim to be paid by the health professional, an insurer, or another entity on behalf of the health professional; or If your clinical practice privileges have been suspended or reduced; or If you've been involuntarily terminated or asked to resign. You will have ten (10) business days to report this information to the Board. Failure to do so can result in fines. The fines are prescribed by the regulations. The first violation is a \$2500 fine. The second violation is a \$5000 fine. The third violation is 10,000 and will continuously be 10,000 for any subsequent violations. If any of those events happen to you, you must report it to the Board of Pharmacy within ten (10) business days. If you have an employee who action has been taken against, the action must be reported within ten (10) days. Both the employer and the employee can be fined for failing to do so. This rulemaking will be enforced with respect to the pharmacy professionals.

1207-O-03	Vice Chair, Mr. Alan Friedman reported that the Legislative and Regulatory Subcommittee has reviewed all public comments that were submitted regarding pharmacists prescribing hormonal contraception. The Subcommittee drafted their responses to the comments submitted. As this matter is a joint effort, the next step is to work with the DC Board of Medicine. Board Chair, Dr. McCants recommended that the Legislative and Regulatory Subcommittee reach out to the DC Board of Medicine Board Chair, Dr. Anderson to determine her availability and include the comments received and the Board's recommendations. Senior Assistant General Counsel, Ms. Williams reported that office staff made several attempts to obtain Dr. Anderson's availability but has been unsuccessful. The DC Board of Medicine Board Chair, Dr. Anderson, is requesting that both chairs establish a scheduled date and time to meet.	Mr. Alan Friedman

	Board Chair, Dr. McCants requested that the Subcommittee gather proposed dates and times for January 2024 and include her in the e-mail communication to determine Dr. Anderson's availability. The Board Chair, Dr. McCants, inquired regarding the status of the workforce survey. Vice Chair, Mr. Friedman reported that Dr. Ortique did a nice job working with his team to develop a PowerPoint presentation where the information was distilled and summarized. Mr. Friedman further reported that the subcommittee reviewed several other jurisdictions of how they've addressed workforce development and will tailor the survey to the district's needs. The next step for the subcommittee is to draft language for the Board to consider.
