A Agenda Item: Moment of Silence for Anibal Miramontes of Fight Fax:

- A Moment of Silence was observed in acknowledgement of the passing of Anibal Miramontes of Fight Fax. Deputy Commissioner Brown stated that Anibal last served as an IBF Ratings Chairman. He was with the IBF for approximately a decade. However, his roots in boxing run deep and for many years. He further stated that Anibal was well known throughout the boxing community globally and his knowledge of the sport was extensive and thorough. This is a sad loss for the boxing community as a whole. He was a respected boxing official who worked many championship fights, and was a renowned boxing record-keeper for Fight Fax, the official recorder keeper for the Association of Boxing Commissions initially.
