Green/Healthy/Sustainable School Recognition Program

- Program name: Capital LEAF (Leaders in Environmental Actions for our Future)
- Stakeholder group meeting regularly to develop application forms (targeted completion by end of November)
- Scope of work developed and market research conducted to find a vendor to assist with a program field test for this school year
- Teacher resources will be drafted with the current Environmental Literacy Leadership Cadre (cohort 3) (targeted completion by end of June)



Environmental Literacy Advancement Grant

- Purpose: To increase the capacity of nonprofit and community-based organizations to provide environmental education programs to District elementary schools represented in the 2019-21 Environmental Literacy Leadership Cadre and alumni schools.
- **Timeline:** Two-year grant beginning October 2019 and ending September 2021.
- Funding: For fiscal year (FY) 20 and FY 21- \$540,000 available, \$429,963.40 was awarded.



NEPA Grant

- Purpose: Two-year grant that focuses on building capacity of schools to provide quality nutrition education and physical activity programming.
 - Each grantee is required to partner with five schools.
 - Three of the five schools must be one or two star schools on the STAR Framework.
- Timeline: The Request for Applications (RFA) for the FY21 competition will be available in Fall 2020.
- **Funding:** \$30,000 per year to 10 community-based organizations.



School Garden Grant

- Purpose: Provides school garden programs with staffing
- **Timeline:** Award Period: Oct. 1- Sept. 30 (two years)
 - Application opens: June
 - Applications due: September
- Funding: \$299,943 awarded this grant cycle



National School Lunch Program (NSLP) Equipment Assistance Grant

 Purpose: To make a significant investment by allowing the purchase of capital equipment used to serve healthier meals, meet the nutritional standards with emphasis on more fresh fruits and vegetables in school meals, improve food safety, and expand accessibility to food services.

• Timeline:

Grant opened: Oct. 9, 2019

Grant closes: Nov. 22, 2019

• Funding: \$100,000 grant split-funded between USDA and HSA funds.

FY 2020: USDA: \$70,451.00, HSA: \$29,549



Cafeteria Staff Training Grant

 Purpose: To provide school foodservice/nutrition employees with knowledge, training, and tools they need to plan, prepare, and purchase healthy products to create nutritious, safe, and enjoyable school meals. To achieve this, the focus of the grant is to fund training sessions for school foodservice/nutrition employees at schools participating in the NSLP and HSA.

• Timeline:

Grant opened: Oct. 15, 2019

• Grant closes: Dec. 6, 2019

• **Funding:** FY 2020: \$100,000



Farm Field Trip Contract

- Purpose: Farm field trips provide an opportunity for District students to understand how a variety of foods are cultivated, learn about the importance of consuming locally grown food, and explore the landscape within and around the District as a space for growing and raising food.
 - The Farm Field Trip Program Contract provides:
 - Farm field trips for students at District schools and child development facilities.
 - At least one pre-trip learning activity and at least one post-trip learning activity.
 - Transportation, if required.
 - FY20 Farm Field Trip Program Scope of Work:
 - Minimum of 2,000 students from DC schools and child development facilities with at least 40
 percent of participating students from priority list of schools/child development facilities provided
 by OSSE.
- Funding: \$30,852 in the 2018-19 school year.

DC Healthy Tots Act

In July 2014, DC Council passed the **Healthy Tots** Act, a comprehensive child development facility health and wellness legislation that is aimed at supporting child care facilities' ability to serve nutritious meals and to offer high-quality health and wellness programming.







What does the Healthy Tots Act do?

- Provides pathways to expand CACFP participation
- Enhanced Meal Reimbursement
 - Add10
 - Local5
 - FullDay4
- Competitive grants to fund activities in five different program areas.



Case Study: Good Karma Enterprises (Center for Social and Emotional Wellness)





Community Level: The Healthy Teachers Healthy Tots Wellness Program

Seeks to create a culture of wellness by addressing the following:

- Staff stress management and coping skills
- Developing wellness champions to promote wellness within each center
- Exposing the children to yoga as a physical activity.

The Healthy Teachers Healthy Tots Wellness Program provides:

- Workshops
- Monthly wellness challenges,
- An online wellness community (Well Space App)
- An early childhood yoga program (Mocha Yogis)



Organizational: Leveraging Local Funds

- OSSE is tasked with awarding and managing the Healthy Tots Wellness Grant. They provide the funding and structure for CBOs to implement programming.
- Sample grant activities in the RFA include:
 - Assisting in the implementation of a Wellness Council
 - Developing a Facility Wellness Policy
 - Implementing a staff wellness initiative
 - Coordinating family engagement activities
- Grantees are expected to create training materials and provide targeted technical assistance in order to help centers successfully complete activities.



Interpersonal Level: Targeted Engagement

Outcomes

- More than 175 staff members received four trainings in the following areas:
 - Stress Management/Aromatherapy
 - Healthy Movement Qigong
 - Healthy Eating
 - Incorporating Yoga into Early Childhood Education
- Multiple well attended Parent Wellness Days at various child development centers
- Continued stream of wellness materials and resources provided that were sent home to families

Program Sustainability

- Ongoing Access to Well Space
- Trained Wellness Advocates
- Facility Wellness Policy
- Materials and resources to independently implement yoga program



Individual Level: The Impact on the Child

Children benefit from the staff wellness program because:

- Teachers who are in a good state of health and wellness and are more effective in the classroom
- A culture of wellness is actively promoted by staff, administrators, and families in and out of the Early Learning Classroom
- There are increased opportunities to model positive health behaviors
- It results in life-long health and wellness for children, families and teachers

Collaborative targeted interventions at various levels of the system
