Agenda Item: Comments from the Public

- Maurice McDonald updated the Board about criminal sanctions and fines imposed for individuals and companies
 working at District jobsites without proper licensure and suggested the Board reach out to its constituents in the
 Trades. Board member, Brian Cooper, recommended that OPLA send information to contractors reminding them
 of compliance. MPD and the Executive Office of the Mayor is working with trade unions in planning an industrial
 trades' job fair. Kia Winston suggested that planners reach out to the apprenticeship council for a comprehensive
 list of training programs.
- Liz Johnson, permit expeditor, requested additional information on obtaining permits and a professional
 contractor's license. The Board reviewed the documents and steps required to apply for an elevator contractor
 license.
- Thomas Johnson had questions regarding requirements for Class 7 licenses and OPLA's online.

• Upon a motion duly made by Board member Robert Smith and properly seconded by Board member Brian Cooper, the Board unanimously voted to approve minutes as amended for the October 17, 2017 meeting.

Agenda Item: Old Business

• The elevator and electrical application deadline was extended to 12/31/17. OPLA is tracking the elevator and electrical renewal statistics. Robert Smith suggested that application instructions be available to users and that OPLA create a video to help applicants apply. (ECC900034).
- Upon a motion duly made by Board member, Brian Cooper, and properly seconded by Board member, Richard Jackson, the Board unanimously voted to request a Notice of Intent to take Disciplinary Action to revoke Ralph Threatt's license and limit the ability to reinstate his license for a period no less than 5 years and issue a \$15,000.00 fine.
