5. Public Comment: (40 mins. –7:00-7:40PM)
 - a. Sgt. Brett Parson, Strategic Change Division, Executive Office of the Chief of Police, Metropolitan Police Department + Q&A (30 mins.)

Discussed special liaison units. Trends of violence is increasing that is bias-related. LGBTQ is traditionally the 3rd nationally, but in DC it is number 1. The question becomes: do we have a problem? Is this bad? Reasons possibly include: 2015 comprehensive re-training on bias-related crime and educational campaign in communities; Increased competency; More crimes are being reported by third party and by the internet/social media. The more success we have with reported cases, the more likely people are to come forward and report. Additional research to un-

derstand why DC remains the highest in statistics for LGBTQ-related crimes. When crimes happen, Sheila Reid-Alexander will be contacted directly. This will support activating a collective response to care. Discussion about protecting LGBTQ identity — this may limit how a report is made or investigated.

b. Additional Public Comments: (15 mins. 7:30-7:50PM)

Director Michelle Garcia, Office of Victim Services. Mission is to increase public safety — provide grant funding to programs that support survivors of crime. Resources that are available: DC Victim Hotline (24/7 by phone/text/chat) with option of warm hand-off to increase ability to access connections 1844-4HELPDC, private security program rebate program — also available for residents on voucher program, ASK DC and ASK U. New programming developed as a result from attention being brought up re: number of missing youth. Community-based projects are encouraged to apply for funding.

Indira Henard, Executive Director of DC Rape Crisis Center. Oldest rape crisis center in the nation. Provides individual and group counseling on sexual assault, as well as secondary survivors. FREE services. 24/7 hotline. Community engagement and prevention work. Majority of client identify as people of color and LGBTQI. If you need support engaging in conversation around to sexual violence issues. Issues raised: sexual assault from gay men on dating apps. Increased awareness is encouraged. Therapists are licensed, trauma-informed, and survivor centered.

Other public comment:

McKenzie Becker: Children's Law Center — Fellow discussed issues facing LGBTQ youth in foster care. Additional work on how CFSA places youth — especially LGBTQ youth. Emphasizing how attorneys can improve services for LGBTQ youth in foster care.

David Mariner, Executive Director of DC Center: summary of services provided as a result of Office of Victim Services, in collaboration with DCRCC. Encouraged further partnership. Taking the Stage, Taking the Stand (Busboys and Poets). Expression nights. V-PART Meetings. This committee can play an active role in de-criminalizing sex work.
