
Safer Stronger DC Office of Neighborhood Safety and Engagement

The Office's mission is to foster a community-oriented model to violence prevention and public safety. Our strategy is rooted in a public health approach to violence prevention, recognizing that reducing crime is not accomplished solely through law enforcement.

ONSE Core Functions

Pathways Program

focuses on up to 50 individuals most at risk of being involved in violence through health-based approach focusing on multiple services. Goal is to decrease the likelihood of individuals' criminal justice involvement and improve outcomes such as employment, education, job opportunities, health, and housing stability.

Violence Intervention & Prevention

reduce violence by establishing strong presence in communities with high levels of violence. Partner with residents, government agencies, and community-based organizations to reduce violence by building relationships with individuals and families most at risk of being directly affected by violence.

Community Stabilization Program

framework for District's emergency critical response planning in response to all homicides and any shootings suspected of being gang/crew related. Facilitates crossagency critical response teams to immediately connect families to government programs and services.

Street Outreach & Case Managers

serve as intensive case managers for up to 50 Pathways Program participants. Street outreach teams connect individuals and their families to services, and foster community-oriented public safety by supporting community-building activities in neighborhoods most at risk of violence.
