#### **Agenda Item: Report - Applications for Licensure**

Upon motion duly made at 9:47 a.m. by board member Dr. Joseph Drew, and seconded by Antonia Browning Smiley, the Board unanimously voted with congratulations to approve the June 3, 2022, list of accountancy applications for licensure, attached hereto and made a part of the June 3, 2022, minutes.

#### **Agenda Item: Old Business**

- A. CPA Exam Performance Summary: Q -1: Dr. Joseph Drew reported on the progress of his letters sent to NASBA, addressed to John Johnson, expressing concerns about the low passage rates. Mr. Johnson indicated he would investigate the historical record on the passage rate and get back to him and also encouraged Dr Drew to bring the topic up at the Regional Meeting in June. Dr. Drew also inquired about the District of Columbia and why we are doing so poorly with international candidates. No response yet to that question.
- B. NASBA's response to Ukrainian Crisis for International CPAs: Angela Meggett-Strudwick reported on hearing from NASBA on the Ukrainian crisis. NASBA does not, per DC's contact, since the CPA credential is governed at the state/jurisdiction level. The decision would be up to each jurisdiction to determine how they would want to handle it. This is something that would need to be addressed at the state level, per NASBA. Dr. Joseph Drew asked if there was a possibility for DC to extend an offer of a temporary license to practice as a CPA for a year or two (2). Chairman Robert Todero didn't think that would be feasible and Patrick White added in the chat that the DC Municipal Regulations do not allow for the Board to provide this type of temporary relief. If NASBA were supporting it, we would need to bring it to the Council/Mayor to support temporary legislation for Ukrainians.
