XVII. New Business (Chairman/Director)

- A) Director Ross gave a presentation on a proposed D.C.-specific transition course. Among the key points were the following:
 - 1. Trying to reach veterans before there is a problem.
 - 2. Making DC a Vet Friendly City
 - 3. Trying to develop a pipeline for veterans from service to DC

- 4. New initiative is called "DC Welcomes Vets"
- 5. Initial objectives:
 - a. Identify gaps in veterans' programs
 - b. Make website user-friendly
 - c. Study tax breaks like those offered by states
 - d. Develop a specialized driver license and vehicle registration for veterans
 - e. Offer discounts on hunting permits
 - f. Develop specialized housing
- 6. Mr. Khan had printed a list of all current benefits offered by DC (Military.com)
- 7. Suggestions to ease transition:
 - a. Letter from the Mayor inviting them to DC
 - b. First-time home-buyer program
 - c. Property/income tax discount
 - d. Educational benefits
 - e. District Government Agency positions
 - f. Integration with governmental services
 - g. Benefits for disabled veterans' children
- B) This led to a discussion of the greatest problems for DC Veterans. Suggestions included the following:
 - 1. Inability to access benefits
 - 2. Bureaucratic barriers
 - 3. Not a lot of data
 - 4. Housing

XVIII. Committee Reports (Vice Chairman): Committee chairs gave oral updates on committee actions

- A) Government Affairs (Mr. Khan)
 - 1. The committee looked into veterans' benefits in DC and Illinois.
 - 2. The committee is looking into ideas for reducing the age for veterans to get some benefits.
 - 3. The committee is also looking at benefits given to veterans globally.
 - 4. One idea is to look at what the city offers disabled people as a whole and add veterans to the qualifying recipients
 - **a.** Two benefits not listed as potential veterans' benefits include 50% off property tax and two years' free (vehicle?) registration for disabled veterans.

b. Mr. Curry noted that you do not have to be 100% disabled for some of these benefits. He was able to get the discount. Such benefits typically read "Senior/ Disabled Vet"
