Appraisal Sub Committee Audit Preliminary findings:

- Area Number 1 (Policy Statements, Regulations) Within compliance Suggestion: clean up typo and language acronym reads AQP should read AQB. 2320.1 remove the appraisal institute name in the language as it is not a member of the appraisal foundation.
- Area Number 2 (Temporary Practice) Within compliance
- Area Number 3 (National Registry) Within compliance reporting of disciplinary actions - area of concern removed.
- Area Number 4 (Application Processing) Within compliance most are reciprocal. Trainee check list was not updated to include the Supervisor trainee course. Renewals look good with 28 plus USPAP course documented.
