- 6. <u>Commission Business</u>: The Commission did not have any items in the agenda.
  - (Old Business) Making recommendations for the Comprehensive Plan, Budget and Engagement Forum and procedures -- Vice-Chair Gopaul revisited the importance of the Budget and Engagement forum (6:00 PM 2/18/2021 and 11:00 AM 2/20/202) and including community organizations and stakeholders in the process by generating a survey and receiving feedback so that it can be used to generate recommendations to the Mayor Bowser.
  - Commissioner Gopaul will share a list of organizations that the Commission can collaborate with the Commission.
  - Associate Director Gaines shared that the MOAAA performance oversight hearing will be on February 24 at 12:00 PM and the oversight hearing will be in April. Additional information will be shared in the MOAAA bulletin.
  - Commissioner Ronald King shared that the COVID-19 vaccine is now available for additional populations such as grocery store employees.
  - The vaccine will be released at different times on 2/18/2021 to accommodate residents' schedules. The schedule will return to normal 2/19/2021

  - Ms. Brenda Jones requested to gain more information regarding Mayor Bowser's Building Blocks DC initiative to reduce gun violence. Associate Director Gaines will share more information.
  - Associate Director Gaines shared information about the Gun Violence Prevention Center in Anacostia which will focus on initiatives regarding Gun Violence and victims of gun violence which will include wrap-around supports and mental health care across Wards 7 and 8.
  - Brenda Belton, Resident, shared that a lot of DC's senior citizen residents are willing to volunteer to help the Commission with any of its outreach projects.
  - Commissioner Holmes (ANC 7C) inquired about the MOAAA's funding during the fiscal year and signature programs offered by MOAAA which will aid in his advocacy for additional funding for the office.
  - Associate Gaines and Commissioner Gopaul shared programming and funding information
  - Alfred Swailes, Community Advocate, suggested that he and MOAAA collaborate to create an empowerment conference for African American residents.
