# DBH Child and Youth Services Division

- The Department of Behavioral Health is building a system of care for children, youth and their families that supports prevention and early identification of behavioral health needs, and provides community based treatmentand supports that are able to meet multiple and changing needs. We are guided by the principles that services must be easy to access, culturally and linguistically competent, and family-driven and youth-guided.
- A range of treatment and support services for children, youth and their families are
  available, including specialized evidence-based practices for youth and families
  recovering from trauma, emergency care and ongoing treatment primarily
  through certified, community based mental health providers. Ongoing treatment
  includes individual, group, and family counseling, diagnostic assessment medication
  management, and family support. In addition, community based providers are certified
  to provide substance use disorder treatment. The Department also operates a children's
  clinic, provides services in public and public charter schools, and manages an alcohol,
  tobacco and drug prevention and awareness campaign called Drug Free Youth DC.

## The Coordinating Council on School Behavioral Health

- The Comprehensive Plan to Expand Early Childhood and School-Based Behavioral Health Services, developed by the former Interagency Behavioral Health Working Group, established a coordinating council to guide implementation of the plan.
- The charge and purpose of the Coordinating Council on School Behavioral Health is to hold agencies and participating stakeholders accountable for timely implementation of the expanded School-based Behavioral Health System.
