#### **New Business**

<u>Spring 2018 Newsletter</u> – The Spring 2018 Newsletter for the District of Columbia Board of Accountancy was sent out by NASBA to all licensees and state boards on March 19, 2018. A printed copy was presented to the Board.

NASBA ED Conference 2018 Report – The discussion of a technology pathway for acquiring the CPA was discussed at the 36th Annual Conference for Executive Directors and State Board Staff meeting. Ms. Kari Bedell weighed in on the discussion and Mr. Cooks, who attended the conference, also provided an overview of the discussion that took place. This agenda item is tabled for discussion for the next meeting.

George Washington MAccy Event- On April 26, 2018, the staff participated on behalf of the DC Board of Accountancy at the George Washington University (GWU) Master of Accountancy Speaker Series. The presentation consisted of the purpose and workings of the Board of Accountancy, its composition, meetings, and processes involving licensure, application processes, and enforcement on protecting the welfare of the public in Washington, DC. The presentation also included application requirements, education and experience requirements for licensure. Invited speakers included Adell Battle CPA, CGMA, Senior Manager Exam Content from the American Institute of Certified Public Accountants (AICPA) and Shelly Crosby Manager, Licensing Services from the National Association of State Boards of Accountancy (NASBA) Experience Requirements- Review of regulations — The board discussed changes to the existing experience requirements in the Municipal Regulations as part of the licensure requirements. Further review, recommendations and discussion ensued.
