Upon motion duly made by member, Bridgett Gagne, and properly seconded by member, Angela Avant the Board voted to establish a 10 year duration for accepting the required experience obtained, proceeding a CPA Application. Dr. Drew voted Nay. Motion carried. The Motion passed with 4 votes in favor and 1 against.

Upon motion duly made by member, Angela Avant, and properly seconded by member, Antonia Smiley, the board unanimously voted to approve the reinstatement application.

Upon motion duly made by member, Bridget Gagne, and properly seconded by member, Angela Avant, the Board unanimously voted that it had no jurisdiction regarding the complaint submitted before the Board – Charles P. Myricks vs. the DC Board of Accountancy.

Upon motion duly made by member, Bridget Gagne, and properly seconded by member Angela Avant, the board unanimously voted to issue a consent order, imposing a fine of \$1500, a reprimand and 3 months for Mr. Wang to obtain a CPA firm license, based on a complaint and subsequent investigative report issued on the case of Neng-Hsiang Wang, CPA vs the DC Board of Accountancy.
