The District of Columbia Board of Accountancy (Board) held its regularly scheduled meeting on Friday, July 10, 2026. This was a virtual meeting.

The meeting was called to order at **9:04 a.m.** by Board Chair **Robert Todero**, and attendance was taken.

- **Legislative Update** – Ms. Randall provided an overview of the legislative process for the amendments currently under review. She outlined the step-by-step timeline and key actions involved in moving the amendments forward.

Accountancy Practices Amendment Act of 2025 (Permanent Bill)

The first reading passed on June 30, 2026. The final vote is scheduled for July 14, 2026, after which the bill will proceed to the Mayor and then Congress for a 30-day review. The Act is expected to take effect in Fall 2026.

Business Licensing Reform & Accountancy Emergency Amendment Act of 2026

The Council will vote on July 14, 2026. The emergency measure authorizes mobility and alternative pathway provisions and, upon the Mayor's approval, will take effect for 90 days.

The Legislative Affairs & Policy Division will coordinate with OPL and Communications to issue the advisory notice.
