Agenda Item: Old Business

Upon motion duly made by Ms. Borton and properly seconded by Mr. Nesmith, the Board voted unanimously to approve the academic evaluations services report/research of organizations completed by Ms. Bryant providing evaluative services of non-accredited Landscape Architecture schools/programs, contingent upon legal review and the evaluating organization providing a statement that their evaluation is substantially equivalent to a Bachelor's degree program in Landscape Architecture offered at a LAAB-accredited institution in the United States, based on the criteria in effect at the time the degree was awarded.

Chairman McGhee and the Board members acknowledge the DCRA staff for the outstanding work on the research of the Academic Evaluations Services organizations.

Agenda Item: New Business

Report: NCARB meeting – 4 resolutions were passed including:

- 1) Resolution 2018-1- NCARB Legislative Guidelines and Model Law/Model Regulations Amendment HSW Category Realignment; passed.
- 2) Resolution 2018-02) Certification Guidelines Amendment Revision to the EESA Requirement for the Education Alternative to Certification; passed.
- 3)Resolution 2018-03 Amendment and Restatement of the NCARB Model Rules of Conduct passed.

4) Resolution 2018-04 – Amendment and Restatement of the NCARB Bylaws – passed.

Mr. McGhee was re-elected as Treasurer of Region 2. A presentation was made by Chairman McGhee to the assembly of delegates regarding the hosting by the DC Board on the NCARB 100th anniversary in June 2019, in Washington, DC. A promotional video of the city was also presented. The presentation by DC delegates was well-received.

All of the aforementioned resolutions were discussed with Region 2 before voting during the business session of the conference.

Report: CLARB/ASLA Licensure Summit – The value of regulation of landscape architecture. Mr. Lewis attended the CLARB-ASLA (American Society of Landscape Architecture) Licensure Summit, where considerable discussion and information was discussed regarding the need for licensure of Landscape Architects, as well as the need to educate the public and legislative bodies on the value of licensure. Some of the recommendations included having a Landscape Architecture Day, dialoging with the local chapter of ASLA, co-sponsoring courses on Landscape Architecture, and educating legislators and the public on Landscape Architecture. The deregulation of licensed professions was discussed, where there is a push nationally to deregulate certain professions, including landscape architecture. Mr. Lewis disseminated booklets on landscape architecture for educational purposes. Additionally, dialogue was started with the local chapter of ASLA representative at the summit (Potomac Chapter) on projects that can be worked on regarding licensing and education for landscape architects with the Board. Mr. Lewis also informed the participants at the summit that the DC Board had already asked a representative of the Potomac Chapter, when licensure is implemented, to serve on some education committees of the Board.

Regarding the CLARB Bylaws Vote, the Board authorize Mr. McGhee as the voting delegate at the upcoming CLARB Annual Conference. ? Was there a motion? If not, leave as is. I didn't see the verbiage.
