#### Agenda Item: New Business

Regarding the Integrated Path to Architectural Licensure (IPAL), the following motions were voted on:

Upon motion duly made by Mr. Williams and properly seconded by Mr. Nesmith, the Board voted unanimously to approve an amendment to the regulations (DCMR Section 3403.1(c) to allow students enrolled in a NCARB-approved Integrated Path to Architecture Licensure (IPAL) program to take the Architectural Registration Examination (ARE) prior to graduation.

Upon motion duly made by Ms. Cohen and properly seconded by Mr. Nesmith, the Board voted unanimously to relax the current regulations to allow students enrolled in a NCARB-approved Integrated Path to Architecture Licensure (IPAL) program to take the Architectural Registration Examination (ARE) prior to graduation.

Oral reports from the NCARB Regional Summit were provided by Chairperson McGhee, Mr. Williams, Ms. Cohen and Mr. Lewis. In preparation for the upcoming NCARB Annual Business Meeting (ABM) in Detroit, the attendees reported that there are four draft resolutions that will be reviewed by the Board prior to the ABM. They are:

- 1) Resolution 2018-A: NCARB Legislative Guidelines and Model Law/Model Regulations Amendment-HSW Category Realignment
- 2) Resolution 2018-B: Certification Guidelines Amendment-Revision to the EESDA Requirement for the Education Alternative to Certification
- 3) Resolution 2018-C: Amendment and Restatement of the NCARB Model Rules of /Conduct
- 4) Resolution 2018-D: Amendment and Restatement of the NCARB Bylaws

The Member Board Executive (MBE) Workshop was attended by Mr. Lewis, which included a focus on reasonable regulation, building connections within the MBE community, the disciplinary database and disciplinary trends, and the importance of continuing education in preventing public harm.

Additionally, Chairperson McGhee was nominated for the Region 2 positon of vice chair/treasurer. The election will be held during the ABM.
