During the closed session, the task force reviewed the following crashes investigated by the MPD Major Crash Unit:

- D17-28 from October 23, 2017, in which a motorcyclist was fatally injured in a collision with a fixed object
- S17-14 from September 1, 2017, in which a motorcyclist was seriously injured in a collision with a fixed object
- SCI-17-1 from June 2, 2017, in which a driver in private space was fatally injured in a collision with a motor vehicle.
