


NUMBER OF EVIDENCE-BASED TRAININGS FACILITATED

■ General trainings ■ Senior oriented trainings ■ Parent oriented trainings ■ Community oriented trainings





DROP-IN CENTERS INDIVIDUALS SERVED




DROP-IN CENTERS REFERRALS




Transitional Housing Nov. 2024-May 2025

NUMBER OF INDIVIDUALS SERVED






TRANSITIONAL HOUSING- NUMBER OF REFERRALS




NUMBER OF INDIVIDUALS ENGAGED THROUGH PEER OUTREACH



DC Youth Residential Treatment

HYPPER- Helping Young People Perform, Excel, and Recover

HYPPER Youth Recovery Services Overview

- Local youth (adolescents, young adults aged 12 - 25) SUD programs.
- Treatment includes counseling, therapy, recreational activities, academic support.
- Care involves multidisciplinary teams and community partnerships (Children's National Hospital) for support.



Multidisciplinary Team and Residential Support

FCRS will staff a multidisciplinary team including:

- Therapists specializing in adolescent SUD and mental health
- A physician in addiction medicine
- A pediatric psychiatric nurse practitioner
- An education coordinator working with DCPS

Residential monitors will provide 24/7 supervision, mentorship, and support with daily living, reinforcing therapeutic goals in a safe, structured environment.

The Nehemiah Project of DC Respite Housing with Wrap-Around Services

Location: Ward 7, Washington, DC

Facility: 18-bed, short-term crisis housing

Target Population:

- Individuals in active opioid-related crisis
- Recently People experiencing incarcerated individuals (returning citizens)
- Those awaiting placement in formal treatment or recovery housing
- Uninsured or underinsured individuals lacking documentation

Key Services Provided:

- 24/7 staff supervision
- Access to medical and psychiatric care
- Recovery resource navigation with warm handoffs to MAT, detox, outpatient, and housing
- Individual recovery planning with peer support
- Daily transportation for medical, legal, and treatment needs
- Meals, hygiene supplies, bedrooms rooms
- Daily low-threshold peer-led support groups
- Naloxone access and overdose prevention education





Community Impact, Prevention, and Lessons Learned

Preventing Opioid Use Among Youth

Many participants are parents, siblings, or caregivers. By stabilizing their lives and reconnecting them with treatment and housing, the program reduces youth exposure to trauma and substance use. Several clients have reconnected with their children or regained visitation rights. Former residents have returned post-discharge to support current clients, reinforcing a culture of recovery.

Reducing Risk for Families and Communities

The program serves Ward 7, an area with elevated rates of poverty, housing instability, and justice involvement. By removing clients from overdose-prone environments and linking them to comprehensive care, the program reduces reliance on emergency systems and increases safety and stability within families and neighborhoods.

Program Outcomes (as of June 30, 2025)

- 59 individuals served
- 40 clients linked to long-term treatment (67.79%)
- 188 total linkages to care (medical, psychiatric, inpatient, outpatient)
- 100% received individualized recovery care plans
- O overdose deaths
- 624 group attendances (Recovery & Life Skills)
- 57 naloxone kits distributed; 20+ doses available onsite

Challenges and Lessons Learned

Transportation capacity continues to limit access to external appointments. The team is addressing this through new partnerships and scheduling strategies. Mistrust of traditional systems was reduced by employing peer staff with lived experience. The program has learned

Model, Approach, and Sustainability

Program Design and Evidence Base

The Nehemiah Project of DC's respite housing program is based on the Doorway Program in New Hampshire and follows SAMHSA's Recovery-Oriented Systems of Care (ROSC) framework. The model emphasizes trauma-informed care, peer leadership, and low-threshold access to treatment. Every client receives individualized recovery planning, harm reduction support, and daily engagement.

Core Practices Integrated into the Model

- On-site naloxone access and overdose prevention education
- Recovery education and motivational interviewing for clients not yet ready for treatment
- Daily peer-led recovery and life skills groups
- Warm handoffs to MAT, detox, outpatient, and residential programs
- Case planning and navigation provided by certified peer support staff

Implementation Strengths

- > 100% of clients received individualized care plans
- Over 600 total group attendances in recovery and life skills sessions
- > 15 new community referral partners formalized since launch
- Numerous clients who completed the program have stayed connected—many return to the property to share their experience, offer encouragement, and participate in on-site recovery meetings
- Several former participants have completed vocational training and found meaningful employment and stable lives
- > Strong peer engagement and retention; no overdose deaths among participants


Proposed Impact
