#### **Agenda Item: New Business**

Chairperson Tamora Papas, Andrew Sullivan, Leon Lewis, and Stacey Williams attended the Association of Appraiser Regulatory Officials (AARO) Spring Conference and the Regulatory Training workshop in Denver, Colorado on May 2-5, 2019. One of the topics frequently shared was how other states regulate AMCs and how disciplinary actions are enforced. Some states, such as Idaho, license their AMCs through the banking and insurance state agencies. Another topic discussed was the new virtual reality features that will be made available for trainees using the Professional Application for Real Estate Appraisers (PAREA) to prepare a proper inspection/appraisal report. There will be an upcoming webinar from The Appraisal Foundation regarding the *USPAP Updates Explained*. All are encouraged to register to participate on May 22, 2019, at 1:00pm.

The board decided to postpone the education seminar titled "Ignorance Isn't Bliss," until next year (2020) in order to begin preparations for another seminar for USPAP.

The Board members were given an outline of what information will be posted in this year's 2019 newsletter. Ms. Williams requested the Board members to provide input on what information should be added, deleted, and modified. Tamora Papas will provide "A Special Message from the Chairman" letter to be added to the newsletter.
