Board was reminded of mandatory FARB training that will be held on October 22, 2019 at DCRA and notified that they were registered by OPLA staff to attend.

Agenda Item: New Business

Upon motion duly made by Mr. Forster and properly seconded by Mr. Pietranton, the Commission voted to have Ulani Gulstone and Edward Downs attend the 2020 ARELLO Leadership Conference, which will be held on January 14-16, 2020, in Key West, Florida.

Chairperson Frank Pietranton, Ulani Gulstone, David Forster, Edward Downs, Ericka Black and Leon Lewis attended the Association of Real Estate License Law Officials Annual Conference in Denver, Colorado on September 18-23, 2019. Highlights included:

- Commission members Ulani Gulstone and Edward Downs were voted in as ARELLO Directors for the term of January 1, 2020-December 31, 2020.
- Leon Lewis was voted in as a trustee on the ARELLO Foundation:
- Frank Pietranton and Leon Lewis participated on the Finance Committee;
- All attendees participated on ARELLO's Legal and Regulations Committee and as actors
 on the simulated legal exercises/cases presented by committee members; Ulani Gulstone
 participated in script writing for the actors; the scripts and actors were well-received, which
 contributed toward decision making on legal cases;
- The Commissioner Resource Committee requested additional funding for delivery of an online version of Commissioner College; this will be voted on at the Jan. Board meeting.
- Commission member Ulani Gulstone chaired the Fair Housing Committee where there was a record attendance at this meeting. There was dialogue on several fair housing cases.
- Some of the member jurisdictions reported legislation being introduced, which will facilitate the easier movement across state lines, easier for persons with convictions, sunset laws to allow a pre-determination for licensure, the sandbox bill in Arizona allowing licensees an easy entry into the state, etc.
- Economic and Housing Market Outlook presented by Dr. Lawrence Yun of the National Association of Realtors, where Dr. Yun emphasized that we are currently experiencing the longest expansion ever, 2.9 percent growth rate in 2018 and close to 3 percent for 2020. He indicated that consumer confidence remains high and that there is a super unemployment rate of 3.7 percent. Dr. Yun also reported that commercial realtors reported slower leasing activity in 2019. He predicted one more Federal Reserve rate cut for 2019. Also, California and Connecticut are experiencing housing affordability challenges because of the high price of owning a home and that 10% of homeowners could not make their mortgage payments in 2019.
- Awards were given to the Kansas Real Estate Commission for their introduction to the Alexa app, where questions and answers are provided to the public and licensees.
- Also, Commission members attended the Task Force on Licensure Portability, where Commission member Ulani Gulstone and Leon Lewis are members.
- The attendees reported that it was an excellent conference.
