The District of Columbia Board of Barber and Cosmetology (Board) held its monthly meeting on Monday, May 7, 2018, at 1100 4th Street, SW, Room E300, Washington, DC. In this Public Meeting and Executive Session, the Board discussed new business, applications for licensure, complaints and investigations.

Anwar S. Saleem, Board Chair, called the meeting to order at 10:15 a.m.

Agenda Item: COMMENTS FROM THE PUBLIC

- Mr. Sulan expressed his concerns to the Board about requirements for threading services. Mr. Sulan stated that other jurisdictions do not require licensure for individuals practicing threading. Mr. Sulan expressed concerns about DC regulations requiring individuals to be licensed in esthetics to practice threading. According to Mr. Sulan there is no formal education or schools that offer courses in threading, as the practice has been passed down through cultural tradition. Chairman Anwar Saleem informed Mr. Sulan that the DC Board would discuss the practice of threading to determine what classification the scope of practice would fall under or if any modifications shall be made.
- Ms. Malin Singleton inquired about the practice of Plasma Skin Tightening and how it is regulated by the DC Board of Barber and Cosmetology. Chairman Saleem stated the Board will discuss this issue in Executive Session. Ms. Singleton also inquired about the amount of hours needed to become a licensed Instructor. She pointed out a possible discrepancy with the instructions for an Instructor located on the Board's website. Board Administrator Andrew Jackson informed Ms. Singleton that completing 1,000 hours of an Instructor course is one of the requirements to be eligible to sit for the examination, to become a licensed Instructor within the District of Columbia. Mr. Jackson stated that he would look into website requirements and follow up if any corrections are needed on the website.

 Upon motion duly made by member, Mark Wills, and properly seconded by member, Eric Doyle, the Board voted unanimously to accept the March 5, 2018 meeting minutes.

- The Board voted last meeting (March 5th) to proceed with Budget Autonomy. Chairman Anwar Saleem stated that the Board is looking to go forward with the assistance of Legal Counsel.

- The Body Artist Committee will prepare a draft of requirements for individuals to obtain
 Temporary Licenses, which the Board deferred for further discussion until its June 4th meeting.
- Upon a motion duly made by member, Eric Doyle, and properly seconded by member, Isaac Colon the Board unanimously voted to forward Plasma Skin Tightening procedure to DOH.
- Upon a motion duly made by member, Mark Wills, and properly seconded by member, Eric Doyle
 the Board unanimously voted to draft correspondence in response and opposition to a proposed
 bill, entitled, "Barber and Cosmetologist Prevention of Domestic Violence And Sexual Assault
 Awareness Training Amendments Act of 2018" targeting only the DC Barber and Cosmetology
 industry.
- The Board unanimously voted to explore scopes of practice and licensing requirements to create a specialty license for hair removal procedures.
- A Barber Committee comprised of DC Barber Board Members, Raymond Kibler, Jared Scott, and Mark Wills was created to draft proponents and requirements to allow and offer Barber students, hands-on training in shops, along with traditional educational institutions.
- Board Member Richard DeCarlo recognized Chairman Anwar Saleem for his valiant efforts in working with the Mayor's office to approve a partial travel exemption to allow several Board members to attend the NIC Regional Conference, in North Carolina, in April 2018.
