The 2021 AARO Spring Conference will be held virtually on May 3-5, 2021. Registration links have been sent to attendees.

The board members were notified of the transition from the DCRA licensing system from the old system to the interim system and want actions to be put into place to continue the order of business for applicants and current licensees.

Historic Preservation announcement was sent out to licensees at the beginning of April and registration is still being received. Seminar will still be held on April 23rd virtually and board members have been encouraged to attend. Approximately 365 registrants have registered and completion certificates will be sent electronically.

The board members were given the legislation regarding the Removing Barriers to Occupational Licensing for Returning Citizens Amendment Act (DC Act 23-561) and was notified that it was passed and goes into effect on March 15, 2021.

Tamora Papas represented the Board of Real Estate Appraisers at the Performance Oversight Hearing on March 18, 2021. Chairwoman Papas touched on the topic of social justice and equality within the field of appraising during this pandemic. Hearing was held virtually.
