**Agenda Item: Legislative Rule Making** 

<u>Legislative Update</u> – Ms. Randall gave a brief update to the board regarding the legislative changes to eligibility requirements. The Board of Accountancy's rules code provision does not include a provision that state that amendments to eligibility requirements can be made by rulemaking. The rulemaking process and the timeline for legislative changes could possibly continue into the spring of 2026. The Chair expressed concerns over the timeline for legislative changes required for the spring of 2026, highlighting the potential disadvantage for CPA applicants. Ms. Randall, in response, suggested exploring the possibility of emergency legislation to expedite the process.
